Contract Overview

CSA is a prime contract holder under on the General Services Administration (GSA) One Acquisition Solution for Integrated Services (OASIS) contract. OASIS is designed to address agencies' needs for a full range of service requirements that integrate multiple professional service disciplines and ancillary services/products with the flexibility for all contract types and pricing at the task order level.

The objective of OASIS is to provide government agencies with total integrated solutions for a multitude of professional service-based requirements on a global basis. The services to be provided under OASIS are intended to meet the professional service mission requirements of all federal agencies, including all organizations within the Department of Defense (DoD) and the national security community.

CSA GSA OASIS Contract Highlights

CSA is an awardee in SB Pool 3 for Engineering Services (NAICS code 541330), for Exception A, B and C. CSA can compete for 8(a) and Service-Disabled Veteran-Owned Small Business (SDVOSB) set asides, and direct awards.

- OASIS has no program ceiling, a five-year base and one five-year option. This allows for long-term planning for complex program requirements.
- Low Access Fee - 0.1 percent - 0.75 percent depending on agency agreements.
- The GSA OASIS team can aid in RFP development including performing RFP scope review and uses an estimating tool to help plan contract cost.
- Standardized Labor Categories: 127 SOC occupations among 26 OASIS LCATs and covering over 1,000 traditional industry job titles.
- Reduced administrative burden and acquisition lead time
- OASIS SB contract allows 8(a) direct awards & SDVOSB set asides.
- 541330 NAICS is associated with:
 - SB Pool 3: \$38.5M size standard (military exceptions)
