

1. Introduction

This is the Acceptable Use Policy (AUP) which applies to your use of our Mobilleo application, which is owned by FOD Mobility Group, a company registered in England with registered office at 3rd Floor, The Waterfront Building, Salts Mill Road, Shipley, England, BD17 7EZ, with company number 02712473.

In this Acceptable Use Policy, when we refer to "FOD Mobility Group" or to "we", "us" or "our", we mean FOD Mobility Group Limited. When we refer to "you" or "your", we mean you as user of our Mobilleo application.

By using the Mobilleo application, you agree to be legally bound by this Acceptable Use Policy.

2. General Guidelines
