Is it legal to share pdf books

Is it illegal to share pdf books.

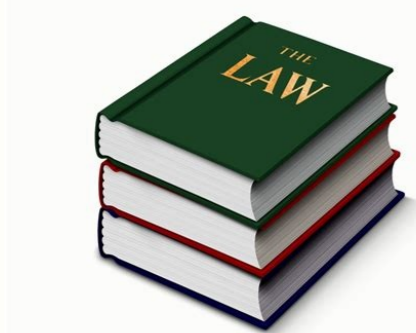
Something went wrong.
Wait a moment and try again. Assuming you are in United States, yeppers, according to federal law you are able backup files you have purchased under the "fair use" concept. You are allowed to make copies for "archival purposes". Like other people have said other places though, you should only be using one version of the material at a time. Calibre basically does this every time you "add a book" to your library (it actually creates a new file, not move the original one). This is not legal advice though, and would recommend looking up some more info here: You can't, in general, know whether a distributor of a work has permission to distribute, or is a pirate site. I verified that they have posted an illegal copy of a work that I created, and I know that I did not grant permission to them (or anyone) to infringe my copyright. Both hosting and downloading works without permission is a violation of copyright law, so both parties are liable. Downloaders may erroneously rely on the "I didn't know!" defense, which in the US carries no legal weight. Even so, if you download my book, it will probably cost me vastly more to sue you for infringement than the damages that I might be awarded over your infringement. Usually, copyright holders go after the pirate sites, and only rarely go after particularly egregious serial downloaders. Scan this QR code to download the app now Or check it out in the app stores If you want to digitize it yourself, you absolutely can under the First Sale Doctrine, provided that you own the copy of the books. I digitize books, so this actually wouldn't be daunting. At this point, however, I haven't started digitizing personal books yet. Yet. I use free, open source tools to process ebooks from digitized books: Homer (sorts pages and performs OCR), ScanTailor(included w/ Homer), Sigil (for editing the epub), Calibre (for converting to mobi and other formats). If it is a print copy you don't care much about, you can cut off the spine, use a flatbed scanner to create tifs. If there is a library or copy center with fast feed scanners, this can be done in pretty short order. If the book is precious to you, you need a rig, which can be as simple as a cardboard box (see the Homer website) and a camera. Overkill?

That depends on the quality of the OCR. :-). That said, you can also check with the publisher.



Smaller publishers offer discounted prices on ebooks if you own the print copy. If you want a digital copy for the short term, check your local library and see if they offer it. Among the things to consider before you scan any book, you need to consider the legal aspect of book scanning, and what you can and cannot do in the eyes of the copyright law. In this article we'll discuss when and how it is legal to digitize books. *The information contained in this site is provided for informational purposes only, and should not be construed as legal advice on any subject matter. Is scanning books legal in the US? The truth is, whether scanning a book is legal in the US depends entirely on what you intend to do with the digitized copy... As a general rule, reproducing a copyrighted book was always considered illegal. However, things turned around dramatically in 2015, when Google went to the US Court of Appeals regarding their book scanning project (an effort to compile a digital library). They made history, making it legal to scan books even if you don't own the copyright. It's important to note, however, that in Google's book scanning project, only restricted snippets of the work were shown, and all written work was attributed to the owner of the copyright. Thus, it's perfectly legal for you to scan a book for personal use and fair use, in the US, and even to give a copy to a friend. Fair use covers socially beneficial uses, such as for teaching. But that's not the full story here, because copyright law is still a very real concern and there are still some strict rules and regulations in place that you must be careful to adhere to when scanning books and using the digitized copies. The key thing to remember, however, is that unauthorized distribution of copyrighted material is strictly prohibited and a violation of the federal law. This covers pirating and the sharing of ebooks through peer-to-peer networks. What's more, all creative content of an ebook must be correctly attributed to the owner of the copyright. These laws are the same across all 50 states. Can I legally scan an old book? Prior to the new ruling on book scanning in 2015, the rules were that any works published prior to 1923 that were in the Public Domain were (and still are) perfectly legal to both scan and redistribute. Who owns the copyright over a book? Once a book has been published, the author assigns copyright to the publisher. It is only when a book is self-published that the author keeps the copyright. If I bought the book, am I allowed to scan it? We did mention this earlier in another FAQ, but it bears repeating here. It depends on what you intend to do with the digitized copy. It's perfectly legal for you to scan a book for personal use and fair use, in the US, and even to give a copy to a friend. But unauthorized distribution is illegal. What can I do with a book after I scan it? Once you have scanned a book, you can use it for personal use and for fair use, such as to aid with your studies, or for sharing with a small group of friends. However, you cannot make a digitized book available on the web unless you clear the copyright. Can I scan a book for my educational purposes only? Scanning a book for educational purposes is a great idea.

Some students do it using their phone, a professional book scanner or the book scanner in the library. It is perfectly legal and should be encouraged. You can also scan a book for leisure purposes. But what you cannot do is redistribute it without permission. Can I scan a book and present it on a zoom call? As we have already discussed, scanning a book for educational purposes is perfectly legal. Thus, if you're on a Zoom call and wish to share the digitized book for educational purposes, then this is permitted. Can I upload a book to the internet after I scan it? Just because internet giant Google has been given permission to scan a great many books to create a digital library does not mean that the same rules apply to everybody equally. This is difficult ground, and you need to tread carefully... The key thing to remember here is that unauthorized distribution of copyrighted material is strictly prohibited and a violation of the federal law. This covers pirating and the sharing of ebooks through peer-to-peer networks. What's more, all creative content of an ebook must be correctly attributed to the owner of the copyright. Yes, there are digital copies of books available for free online, but these are usually either books that were printed before 1923, or books where the copyright was cleared before the ebook was made available online. So it's probably not the best idea (legally) to digitize books and upload them online.



How to scan a book? Once you have covered the legal part of book scanning and decided to scan your books you should learn about the different types of book scanners, the different brands, and the different specifications. Later you should read our guides about how to scan books, how to scan a book on your phone, and how to scan old books. Once you get that covered, consider reading about book scanning software, book scanning phone apps and OCR for book scanning. If you want to get fast results with high quality scanning you might also want to consider a book scanning service to do the digitization for you. These services usually use a professional automatic book scanner that has a high quality camera and speed. They scrape the internet for free pdf files to make it available in their service. I see several books there which shouldn't be there, which means that someone made an unauthorized copy and then put it on their website. Then PDFDRIVE will locate this copy and store it until someone complains. PDFDRIVE will remove things upon request, but of course, many publishers are too busy to complain. The legal consequences may differ depending on what country you in. Generally speaking though, the consequences are more severe for people who share or distribute copyrighted material without permission. If you download it for private use, you are unlikely to pay a penalty. I am speaking generally. I would think of it in another way.

What is the right thing to do? Is the ebook easily available in your country? Is the cost of trying to obtain a legal copy significantly higher than other books produced in your country? Also: what is your status/economic level? Generally if you are a student or teacher, you face fewer legal consequences (if any). If your monthly income is \$500, and the cost to buy a foreign-produced book in your country is \$75, I would consider that price to be excessive. Academic textbooks in particular are expensive for people in developing countries (and many of these publishers try to discount their prices for customers in that region). One way to deal with this ethically is to try first, buy later. If you find an unauthorized copy of an ebook and end up using it a lot, perhaps you will feel a duty to buy it later. Finally, there's a lot of free and low cost ebooks (and wikipedia). While certain well-known books may cost a lot, often there are low-cost books which are equivalent or better. It just takes a little more time to find them.
