## Epstein flight logs

Jeffrey Epstein's flight records have been a subject of intense scrutiny for years. Recently released documents have shed more light on the individuals who traveled on his private plane. The trial of Ghislaine Maxwell, Epstein's alleged accomplice, has added new context to these records. Between 1991 and 2006, Epstein's plane carried politicians, musicians, models, and financiers. Prosecutors have released nearly 120 pages of handwritten flight logs. Each page is signed by David Rodgers, who was Epstein's chief pilot for over a decade. These documents have been made public after prosecutors submitted three versions to the court. Notable names in the flight records include Donald Trump, who first appeared in 1993 and traveled with Epstein and Maxwell multiple times. Trump has admitted to knowing Epstein for many years and called him a "terrific guy." He also wished Ghislaine Maxwell well after her arrest. Bill Clinton was another frequent passenger on Epstein's plane. He traveled internationally several times between 1992 and 1994, often accompanied by someone named "Doug Bands," who has a similar name to a former Clinton aide. Alan Dershowitz, known for helping secure Jeffrey Epstein's deal in Florida, took multiple flights on his private jet between 1998 and 2005. In 2019, Dershowitz said he hadn't spoken to Epstein in years, describing their relationship as academic. However, Virginia Giuffre claims Epstein forced her to have sex with Dershowitz, a claim Dershowitz vehemently denies and has sued Giuffre over. Prince Andrew's name appears in flight logs twice, in February 1999, but it's unclear if he met Sarah Ferguson, his ex-wife, during one of those flights. Meanwhile, Ghislaine Maxwell introduced Giuffre to the prince, with Giuffre including a photograph of the two together in her lawsuit against him. Other notable figures on the flight logs include former Senator George Mitchell and Eva Andersson-Dubin, Epstein's ex-girlfriend who dated him between 1983 and 1991. Government files related to Jeffrey Epstein were released by Attorney General Pam Bondi, but most of the documents have been publicly available for years. The records include flight logs from Epstein's private plane, which were used as evidence in previous court cases. The logs show that Epstein took multiple flights with passengers identified as Jane, who claims she was abused by him at age 14. Ghislaine Maxwell's name appears frequently in the documents, supporting witness testimony about her close relationship with Epstein. Alongside the flight records, a partially censored address book compiled by Epstein and Maxwell was made public. The Justice Department also released a list of over 150 items seized from Epstein's properties, including sex toys and nude images. It is unclear whether these documents are directly related to Epstein or his associate Ghislaine Maxwell's cases. The long-awaited release of declassified files related to Jeffrey Epstein's case was met with disappointment, as the documents largely contained previously leaked information. A note accompanying the release downplayed their significance, stating that the first phase of declassified files consisted of documents that had already been made public through various means. The lack of new information has drawn criticism from both conservatives and online sleuths, who were eager for fresh details about Epstein's crimes and connections to famous individuals. Rep. Anna Paulina Luna expressed her disappointment on social media, calling the rollout a "complete disappointment" and demanding that the government release the information they had requested. Meanwhile, Bondi has ordered the FBI to hand over all remaining records related to Epstein by Friday morning and directed them to conduct an immediate investigation into why her previous order was not followed. Patel has vowed to ensure that all documents are provided to the Justice Department leadership and to uncover any hidden records. The case has drawn widespread attention due to Epstein's links to prominent figures, including royals, presidents, and billionaires. Despite the release of thousands of pages of records over the years, much of the material has already been publicly known, including mentions of notable individuals such as Trump, Clinton, and Prince Andrew. The final batch of documents unsealed in January 2024 included transcripts of victim interviews and old police reports, but much of this information was already public knowledge. Jeffrey Epstein's Private Jet Pilot Reveals High-Profile Passengers Donald Trump was a passenger on the plane once but denied ever meeting him. The pilot of Jeffrey Epstein's private jet, Larry Visoski, has testified that he flew the financier and numerous high-profile figures over nearly 30 years, including Prince Andrew, Bill Gates, Kevin Spacey, and politicians like George Mitchell. Visoski recalled flying Epstein on roughly 1,000 trips between 1991 and 2019 without ever witnessing any instances of sexual activity. He named several famous passengers, including musicians Itzhak Perlman and Chris Tucker, billionaire Bill Gates, astronaut John Glenn, and former US Senator George Mitchell. Donald Trump was listed as a passenger but denied ever meeting him. The trial of Ghislaine Maxwell is ongoing in New York, and Visoski's testimony has shed new light on Epstein's final days. The Justice Department's Inspector General report found that "negligence, misconduct and job performance failures" by the Federal Bureau of Prisons and jail workers allowed Epstein to take his own life in August 2019. Pilot Visoski testified about flying to Little St. James, Epstein's private Caribbean island, which was a regular destination. When asked if he saw sex acts involving underage females, he denied it, saying "Absolutely not." Ghislaine Maxwell is on trial for multiple felony counts related to trafficking underage girls for Epstein's sexual abuse. She allegedly groomed girls and offered them lavish trips in exchange for exploiting them. The 59-year-old has pleaded not guilty to all charges. In court, a witness named "Jane" testified that Maxwell was sometimes present during sexual interactions with Epstein when she was just 14. Denise George, who filed a lawsuit against Epstein's estate, is seeking information on anyone who worked with or interacted with Epstein, including passengers who traveled with him. The flight logs she requested include details of Epstein's four helicopters and three planes, which have been used for various purposes between 1998 and his death last year. Two of Epstein's former pilots have already cooperated with the investigation, providing logs that implicated several high-profile individuals, including Prince Andrew and Bill Clinton. The FBI has released a batch of files related to the Jeffrey Epstein investigation, including flight logs and names of people associated with the late sex offender. According to Attorney General Pam Bondi, the release is part of President Trump's commitment to transparency and follows through on promises made by his administration. The first phase of files includes documents that were previously available to the public through leaks but never formally released. Bondi said the release provides "long overdue accountability" into Epstein's extensive network. Flight logs obtained from the investigation appear to be a significant revelation, with sources suggesting they will reveal the full extent of Epstein's activities. An unnamed legal source told the Mirror that the records will make the ones provided by Roger Stone look insignificant, implying they could implicate numerous high-profile individuals. Virginia Giuffre, one of Epstein's victims, played a key role in encouraging Adam Perry Lang, a celebrity chef, to cooperate with the FBI. Lang worked for Epstein between 1999 and 2003. Attorney General Bondi had faced pressure from lawmakers on both sides of the aisle to release information related to the case. She assured that the files would shed light on Epstein's extensive network and provide public accountability. Epstein's private plane flight logs and phonebook entries were released, revealing connections between celebrities, politicians, and associates. Investigations have shed light on the extent of his sex trafficking ring, with key figures like Ghislaine Maxwell being held accountable. The Epstein documents contain names of people who flew on his planes or had dealings with him. Jean-Luc Brunel, a modeling agent accused of supplying girls to Jeffrey Epstein, was found hanged in a French jail on February 19, 2022. This revelation came after Epstein accuser Virginia Roberts Giuffre testified against Brunel in June 2021. Brunel had previously been arrested in Paris in December 2020 as part of the Epstein probe.
